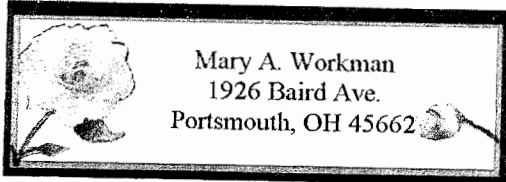


To the City of Portsmouth Planning Commission
